Subject: Notification of changes in the shareholder structure

TEAM Consulting Engineering and Management PCL. ("the Company") hereby notifies that the Company has been informed by the major shareholders including Mr. Prasert Patramai, Mr. Peerawat Premchun, Mr. Thanasarn Khuayjarernpanishk, Mr. Kittipol Bunnim, and Mr. Issarin Patramai that Nexter Ventures Co., Ltd. ("Nexter Ventures"), a subsidiary of Siam Cement Public Company Limited, has purchased the shares from them under the Big Lot Transaction through the Stock Exchange of Thailand on September 7, 2021. The total number of shares purchased were 67,328,800 shares, equals to 9.90 % of the total issued and sold shares, at the price of THB 2.54 Baht per share.

The acquisition of Nexter Ventures will promote the collaboration of both business operations in the areas of engineering, architecture, environment, technology and innovation, such as the environmentally friendly construction technologies.
